MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

The product is made of sheet steel, and the raw materials are transported to the production facility, where the main manufacturing processes include punching, folding and welding before receiving a powder coating and during assembly plasterboard, insulation and components are added. The manufacturing process requires electricity and fuels for the different equipment. Certain ancillary materials are also included. Waste steel generated during production is recycled, and losses of raw materials that

occurred during the manufacturing process and the disposal of waste powder coating as hazardous waste were considered. The finished product is packaged in plastic film and put on wooden pallets before being sent to the installation site by lorry.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurring from final product delivery to a construction site (A4) cover fuel direct exhaust emission, environmental impacts of fuel production, as well as related infrastructure emissions.

The transportation distance is calculated to be an average of 230 km by lorry. Installation guides are available to assist the contractor with the correct installation of the product and any ancillaries.

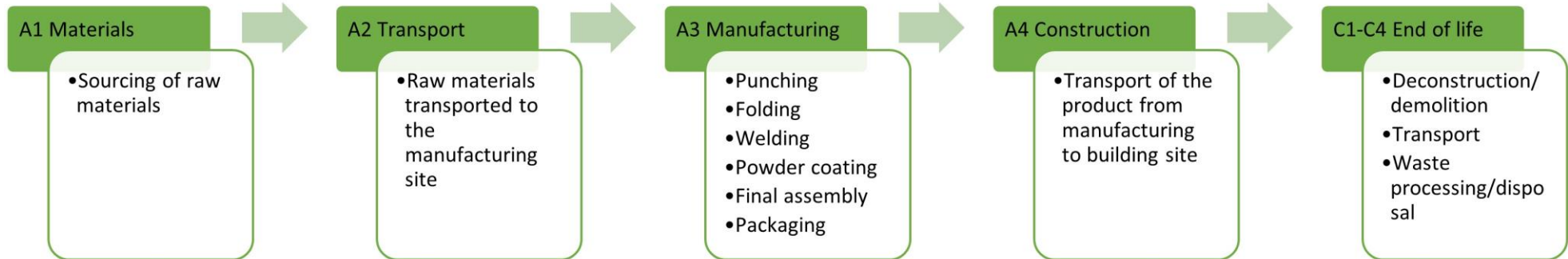
PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use phase. Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

For the removal of the structural products, a conservative estimate for energy (0.001kWh/product kg) for using cranes or wrecking balls was made. It is assumed that 100% of the waste is collected and transported to a regulated waste treatment centre. We took a conservative approach and assumed a 100km distance between the construction site and the nearest waste contractor facility, transported by lorry. At the end of the product service life, it is recommended that the steel is sent to a metal recycling centre, rockwool and plasterboard are sent to a specialist recycling centre. Approximately 92% of steel, rockwool, plasterboard and accessories are assumed to be recycled based on UK Government C&D (construction and demolition) 2020 waste statistics. It is assumed that the remaining 8% of steel, rockwool, plasterboard and accessories are sent to landfill for final disposal. The packaging materials used for this product are recommended to be reused (wooden pallets), recycled or incinerated for energy recovery wherever possible. We have modelled the most likely scenario for these materials based on the current UK market.

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.
